- I understand that following a permanent emigration transfer of my Australian superannuation funds to the NZ Funds KiwiSaver Scheme I will not be able to transfer them to a third country (being a country other than New Zealand or Australia).
- I understand that any "Australian sourced" balance in my NZ Funds KiwiSaver Scheme account will not be able to be accessed until I reach age 60 and satisfy the definition of retirement as set out in the applicable Australian regulations.
- I understand that if I become eligible to withdraw some of my funds to purchase a home, I will not be able to withdraw the amount transferred from my Australian superannuation fund.
- I understand the permanent emigration transfer of my Australian superannuation fund to the NZ Funds KiwiSaver Scheme will not be considered eligible contributions for the purpose of receiving any member tax credits or first home deposit subsidy.
- I understand that NZ Funds cannot provide any assurance as to when my Australian funds will be transferred to the NZ Funds KiwiSaver Scheme or converted into New Zealand dollars. I understand that NZ Funds will not be liable for any decrease in the value of my retirement savings or change in conversion rate that may occur during the transfer process.
- I understand that once my Australian superannuation funds have been transferred to the NZ Funds KiwiSaver Scheme, they will become, with a few
  exceptions, subject to the rules and regulations governing the NZ Funds KiwiSaver Scheme.
- I acknowledge that NZ Funds recommends that I seek independent and professional Australian and New Zealand tax advice and financial advice
  pertaining to my circumstances in relation to the proposed transfer.
